Matopo Ingwe Lodge Terms and Conditions

- 1. Booking Confirmations
 - A 30% deposit is required to confirm a provisional booking if the booking confirmation is outside 14 days of arrival.
 - Full payment of the booking will be required within 14 days before arrival.
 - Booking cancellations are subject to cancellation policy below.
 - No booking will be cancelled or amended unless notified in writing.
- 2. Booking Confirmations Cancellation Policy
 - 30% cancellation fee (deposit forfeit) from 14 to 7 days prior to travel.
 - 50% cancellation fee if cancelled 7 to 3 days prior to travel.
 - 100% cancellation fee if cancelled within 3 days or less prior to travel or any no-shows.
- 3. Third Party Services
 - These include but are not limited to third party Transfers operators, Game Drives or any activities not provided by Matopo Ingwe Lodge.
 - The Company is not liable for any loss, damage, injury, illness (including but not limited to contracting COVID-19), death, disability, loss of support, additional costs, delay, or irregularity that may be the error or default, act or omission whether willful or negligent of any third-party supplier.
- 4. Insurance
 - It is highly recommended for guests to obtain some level of insurance. The guests accept sole responsibility to ensure that they carry the correct fully comprehensive travel and medical insurance to cover themselves, as well as any dependents/ travelling companions. This insurance should cover but not limited to, the following possibilities: delay or cancellation of an activity, emergency evacuation expenses, medical expenses, personal injury, illness (including but not limited to COVID-19), loss of support, death and disability, hometown repatriation costs, consequential loss, damage/theft/loss of personal baggage, money, and belongings.
